STATE OF NORTH CAROLINA BUNCOMBE COUNTY MEMORANDUM OF STREET ACCEPTANCE

THIS MEMORANDUM OF STREET ACCEPTANCE, is made and entered into this day of February, 2022 by and between Buncombe County, a body politic and corporate of the State of North Carolina (herein "Dedicator") and the City of Asheville, a North Carolina Municipal Corporation (herein the "City" or "Acceptor").

WITNESSETH

WHEREAS, Dedicator is the owner of a certain tract of land located in the City of Asheville, Buncombe County, North Carolina, PIN: 9657-43-3150, being more particularly described in deed recorded in Book 5157 at Page 1162, Buncombe County, North Carolina Registry (herein the "Real Property");

WHEREAS, Dedicator has constructed a street on the Real Property, named "Sweeten Creek Industrial Park Road" and "GE Access Road," as same are set forth and described in that plat recorded in Plat Book 220, at Page 50 Buncombe County, North Carolina Registry (herein the "Subject Street") reference to which plat is hereby made for purposes of description of the Subject Street;

WHEREAS, Dedicator has dedicated the Subject Street to the City of Asheville for acceptance as a public street, applied for the Subject Street to be accepted by the City, and paid all attendant application fees set forth in the City's Fees and Charges Manual;

WHEREAS, Dedicator warrants that it has designed the Subject Street to comply with the requirements of the City's Standard Specifications and Details Manual; and

WHEREAS, the City has determined that it is in the public interest to accept the Subject Street as a public street under the terms set forth herein.

NOW, THEREFORE, IT IS UNDERSTOOD AND AGREED BETWEEN THE DEDICATOR AND THE ACCEPTOR THAT:

- I. The Dedicator hereby warrants that the Subject Street has been constructed in conformity with the City's Standard Specifications and Details Manual, and is reasonably free of defects. If any defects in the Subject Street are found, the Dedicator agrees to perform any and all work required to correct said defects, at its own costs. In the event that the Dedicator fails to honor this warranty within thirty (30) days of being notified by the City of an apparent defect, the City shall be entitled to perform the necessary repairs, and invoice the Dedicator for the cost of such work. The term of the warranty set forth in this paragraph shall run for two (2) years, beginning with the date first set forth above.
- II. Separate from, and in addition to the warranty set forth in the preceding paragraph, Dedicator hereby acknowledges that it is self-insured for general liability and maintains excess general liability coverage up to \$7,000,000 per occurrence: Including coverage for bodily injury and property damage. Dedicator further agrees, to the extent permitted by North Carolina law, to indemnify, defend, and hold harmless the City and their officers, agents and employees from any third party claims arising from negligent acts or omissions of the Dedicator arising out of or in connection with the design or the original construction of the Subject Street.
- III. The parties hereto understand and agree that this dedication by Dedicator and the acceptance by City of the Subject Street is limited to use by City's Public Works department in the course and scope of any and all work necessary and appropriate to maintain and clear said Subject Street.
- IV. Subject to, and in recognition of the warranties and covenants set forth herein by the Dedicator, the City hereby accepts the Subject Street as a public street.
