The Buncombe County Commission requests technical advice and assistance from The Trust for Public Land and The Nature Conservancy in connection with our efforts to develop and sustain reliable, ongoing sources of funding for parks, trails, land and water conservation, affordable housing, and related priorities.

As part of your advice and assistance, I understand you will conduct research with affected groups to develop recommendations for the County on strategies for supporting dedicated, ongoing sources of public funds for land conservation.

We are interested not only in the factual information that you can provide, but also your opinions and recommendations on public funding measures available to us and strategies to enact such measures. That would include understanding the public's priorities and attitudes concerning natural and agricultural land preservation, affordable housing, water quality and natural areas—including parks, trails, and fish and wildlife habitat—and how the public would respond to different methods of presenting those issues.

Information provided to the County will be public record as a matter of law. This request does not in any way commit public funds to the efforts of The Trust for Public Land and The Nature Conservancy related to this request, nor does it require public disclosure of any confidential information of either organization.

This request will continue in effect for any advice you offer or presentations you submit for the use of this body related to such matters. In addition, we would like to take this opportunity to request that you continue to be available to provide technical advice and assistance in this area and on related matters in the future.




The Trust for Public Land has helped pass over 610 ballot measures for parks, land, trails and schoolyards since 1996.






Proof of Concept:




KEY Ingredients to a Voter Approved Program

Projects can be selected either before or after a referendum.

If selected before, it is best to have keystone parcels (critical to the project) under contingent contract.

If selected afterwards, it's ideal to have a transparent, accountable process for making choices.



Ideally we want all parts of the community (different communities, urban/rural, different constituencies to be able to see value in the projects. "Put the voters in the picture."

Community support, and support from advocacy groups, is important.

Bonds are most common in North Carolina, and most successful in passing, 88% so far.

A \$30 million bond for capital projects would cost typical household max of \$14 per year for 20 years, \$18 for \$40 million.



Findings and Recommendations from a Poll of Likely November 2022 General Election Voters





Methodology



Impact Research conducted a multi-modal poll of likely 2022 general election voters in Buncombe County, North Carolina.



The sample includes a total of N=400 responses collected utilizing landline, cellphone, and text-to-web interviews.



Interviews were conducted between April 7 - 12, 2022.



The margin of error for a sample of this size is +/- 4.9 percentage points at the 95% level of confidence. The margin of error for subgroups varies and is higher.

IMPACT Research

Primary Question on Open Space Bonds

I'd like to get your opinion on some ballot questions that may be decided by voters in Buncombe County this November. Here is the first one...

Open Space Bonds Proposal:

SHALL the order authorizing thirty-million dollars of bonds plus interest to pay the capital costs of acquisition and improvement of land or interests therein for conservation and protection of natural resources and preservation of farmland, including, but not limited to, the development of greenways and trails for recreation purposes, and providing that additional taxes may be levied in an amount sufficient to pay the principal of and interest on the bonds be approved?

Primary Question on Housing Bonds

Housing Bonds Proposal:

SHALL the order authorizing forty-million dollars of bonds plus interest to pay the capital costs of housing for the benefit of persons of low or moderate income, including construction of related infrastructure improvements and the acquisition of related land and rights-of-way, and providing that additional taxes may be levied in an amount sufficient to pay the principal of and interest on the bonds be approved?

Q4. If the election were held today, would you vote YES in favor of this proposal, or NO to oppose it?



RESEARCH

Huge majorities support virtually every aspect of Open Space Bonds, demonstrating the depth of support for the measure.

Protecting natural resources, wildlife, and farmland generate virtually zero controversy.


OPEN SPACE BONDS PURPOSES

Affordable housing itself is not an obstacle; support for acquisition and development of the land is softer.








