#### • General Obligation Open Space Bond Order

to issue General Obligation bonds for acquisition and improvement of land or interests for conservation and protection of natural resources and preservation of farmland, including but not limited to, the development of greenways and trails for recreation purposes.

#### **OLD BUSINESS**

#### Resolution Setting the Bond Referendum - General Obligation Bonds

Don Warn, Finance Director, explained that for the issuance of General Obligation bonds, it is required to approve a resolution setting a special bond referendum after the bond orders have been adopted by the Board of Commissioners.

Commissioner Whitesides moved to approve the resolution as presented. Vice Chair Edwards seconded and the motion passed 6-0.

## Resolution for the Issuance of the 2022 Limited Obligation Bonds (LOBs) for County and Public School Capital Projects

Don Warn, Finance Director, explained that approving resolution approves the financing of the public school capital projects. A public hearing was held on May 3, 2022, to receive input from the public before the initial resolution was approved by the Board. The County intends to issue private placement bank financing in the form of LOBs in an approximate amount of \$155 million with a 15-year final maturity. The new debt will fund approximately \$25 million in countywide capital projects, \$45 million of public school capital projects, \$85 million in refinancing of the 2014A Limited Obligation Bonds and associated issuance costs.

Vice Chair Edwards moved to approve the resolution as presented. Commissioner Beach-Ferrara seconded and the motion passed 6-0.

## **NEW BUSINESS**

#### Approval of CliftonLarsonAllen LLP (CLA) Fiscal Year 2022 Audit Contract and Engagement Letter

Don Warn, Finance Director, explained that CLA provided the County with an engagement letter and audit contract for the upcoming fiscal audit. The engagement letter outlines the audit services to be provided, audit objectives, auditor responsibilities and management responsibilities. The County's Audit Committee reviewed both items and recommends approval by the Commissioners.

Commissioner Wells moved to approve the contract and authorize the Chair to sign the contract and engagement letter. Commissioner Pressley seconded and the motion passed 6-0.

# • Resolution Modifying the Land Conservation Advisory Board

Ariel Zijp, Farmland Preservation Manager, explained that modifying resolution will create board terms and limits. The Land Conservation Advisory Board is of the opinion that there is a need to update the Board's structure and appointment format.

Commissioner Wells moved to approve the resolution as presented. Commissioner Whitesides seconded and the motion passed 6-0.

## • Budget Amendment for Register of Deeds Excise Stamp Tax

John Hudson, Budget Director, explained the budget amendment.

Commissioner Whitesides moved to approve the budget amendments as presented. Commissioner Beach-Ferrara seconded and the motion passed 6-0.

## • Budget Amendment for Health Insurance Stop-Loss Adjustment

John Hudson, Budget Director, explained the budget amendment.

Commissioner Whitesides moved to approve the budget amendments as presented. Commissioner Pressley seconded and the motion passed 6-0.

#### Letter of Support for New Hospital

Chairman Newman explained that the Commissioners are in support of an alternatively owned facility so the community has a choice.

Commissioner Wells moved to approve the letter of support. Commissioner Beach-Ferrara seconded and the motion passed 6-0.

#### • Attenuation Light for Leicester Volunteer Fire Department

Commissioner Wells explained that the request is to allow the cost sharing of an attenuation lighting system at the intersection of Alexander Road in support of the new Leicester Volunteer Fire Department. Attenuation lighting is utilized to control traffic at intersections in the vicinity of public safety facilities when emergency vehicles are dispatched.

Commissioners discussed the request and asked for staff to provide clarification of details for the next meeting, with the intent to add it as an item to the consent agenda.
