SUBJECT: Approval of January 2023 Tax Collection Report

BRIEF SUMMARY:

NCGS 105-350 requires the Tax Collector to submit a report showing the amount of taxes collected.

The settlement for Mission Health/HCA for prior tax years will continue to be reported as a reduction for prior year collections. Adjustments to the total levy through the remainder of fiscal year 2023 will be due to registered motor vehicle levy and regular property value discoveries or releases.

As of January 31, 2023, the total levy billed for fiscal year 2023 is 96.60% collected, as compared to 95.99% for fiscal year 2022. Notices of delinquency were mailed for fiscal year 2023 in January, notices of delinquency were mailed in February last fiscal year.
