Contract Background

- Franchise waste collections contract started Jan. 1, 2020
- 5 Year contract with (2) 2-year extension options
- Weekly trash and every other week recycling collection in the unincorporated areas of Buncombe County
- BC staff and WP have been negotiating on extension term through CY28



Questions from Nov 7th Briefing

Is there any way to know if weekly recycling will result in more recycling?

It's unclear if it would increase or decrease if it went to weekly.
 With 96-gallon cart collection programs, it's less common that there is weekly pickup for recycling. Also, there is just a lack of data within a similar market to offer a reliable answer.

If we make a change in recycling frequency to weekly recycling, does it have to be system-wide?

 Yes, as the current discussion with Waste Pro is associated with system-wide changes, not multiple services within the same routes.

Questions from Nov 7th Briefing

Specifically with Catawba County, is Republic countywide?

 Yes, Republic is all unincorporated areas in Catawba, they do not pick up in municipalities, a similar model to Buncombe County.
 However, Republic also manages five convenience sites included in their franchise contract.

What are the costs associated with another recycling cart in lieu of weekly recycling for the customer?

 That is currently a negotiation point and Waste Pro to provide what the costs of a subscriber adding a recycling cart for additional capacity

Increased Costs



Necessary rate increases result from the rapidly changing market conditions we have all experienced these last several years.

Stimulus packages fueling a fast-moving economy, combined with labor and supply chain shortages, have drastically changed the industry's cost.

We have seen a significant increase in business costs, including truck, fuel, and labor costs.

Increased Costs



This economic change is evident in contract bids in the last two years, including recent contracts in North Carolina.

The Cities of Kannapolis, Charlotte, and the Town of Matthews all saw substantial increases—between 20% and 40%.

Benefits with Waste Pro




- ✓ While other national companies prefer to be paid by the County, we bill residents individually while absorbing any financial shortfalls.
- ✓ We are an established commercial hauler in Buncombe County, which covers our overhead. Other potential vendors would have to carry the total overhead on this contract, driving up costs that would be passed to the County.
- ✓ Multi-year service cost increase instead of upfront "all at once" cost increase.

- Approximately 2.4 Million total collection service events since Jan1


