## Staff Updates:

**Buncombe County LIFT Applications.** Tim Love, Intergovernmental Relations, provided an overview of the Legacy Investment from Tourism (LIFT) Fund. Previously proposed projects were proposed as future sources that the funding could be applied. The Board had a discussion and was informed of the next steps.

**Community Reparations Commission Update and Extension Request.** DK Wesley, Assistant County Manager, updated the Board on the timeline, county staff and resource support, communication and public engagement, extension request and response, and next steps. Community Reparations Commission members voted to request an extension to December 2024 and stated a detailed justification would be provided, per staff's request. The commission members questioned the need for justification & asked to put the resolution forward as is.

**Q1 Strategic Discussion.** Rafael Baptista, Strategy & Innovation HR Director, discussed a timeline for the upcoming strategic plan with the new commissioners. The Board plans to implement the new strategic plan by the end of November 2024 before the new commissioners take office in 2024. Updated information was provided about the current strategic plan in the areas of Educated & Capable, Resident Well-Being, Environmental & Energy Stewardship, Vibrant Economy, Foundational, and Equity.
