Staff Updates:

Comprehensive Plan Implementation Process. Nathan Pennington, Planning Director; Gillian Phillips, Planning; and Rafael Baptista, Strategy & Innovation Director; provided an update of the process that consisted of the order of the text amendment modules and led the discussion of options for short-term rental conversion incentive.

Waste Collection RFP. Dane Pedersen, Solid Waste Director, provided information for the key items of the waste collection Request for Proposal (RFP) and requested feedback from the Board. The timeline and next steps were presented for the process.

NC CLASS Investment Pool. Mason Scott, Finance, explained the investment pool and informed the Board of the County's investment policy and history. Recommendation was given to adopt the resolution and approve agreement to join NC Class Investment Pool at next regular Board meeting.

Sheriff's Safety Presentation. Herbert Blake, Sheriff Chief Deputy, and Donnie Parks, Sheriff Administrative Investigator, reviewed the handout that addressed the cited problems and concerns expressed by owners, managers, and employees in the Downtown Business District. The Sheriff office is requesting support and funding in the amount of \$186,000.00 from the Buncombe County Board of Commissioners. The requested funds will be used to cover the cost of providing a higher level of law enforcement presence and engagement in the Downtown Business District.
