Subject: Approval of November 2023 Tax Collection Report

Brief Summary:

NCGS 105-350 requires the Tax Collector to submit a report showing the amount of taxes collected.

In the month of November, the majority of mortgage servicing payments have been processed. Public Service Utilities have also been billed, for the current fiscal year. Adjustments to the total levy through the remainder of fiscal year 2024 will be due to registered motor vehicle levy and regular property value discoveries or releases.

As of November 30, 2023, the total levy billed for fiscal year 2024 is 48.87% collected, as compared to 49.59% for fiscal year 2023, as of the end of November. Total levy for personal and real property has increased by approximately 5.0% from fiscal year 2023, as of the end of November.
