#### Map – Stream Migration





## **Current Project Status**

- Right of Way Acquisition and Site Prep in process
- Stream Restoration in process
  - Engineer hired
  - Stream restoration design is underway and will be amended should any changes to the new bridge alignment occur
  - Permitting process in progress
  - ARPA funds: require Resolution, in packet today
- Bridge Construction design in process
  - DOT will partner
  - DPS funds: requires Budget Amendment and Agreement with DOT, in packet today





#### **Documents in Packet**

- Budget Amendment DPS Grant for Barnardsville Bridge: Amend budget to include funds from NC Department of Public Safety
- 2. DOT Agreement Passthrough of funds for construction of the Bridge: Approve agreement with NC Department of Transportation to passthrough DPS grant funds for the construction of Barnardsville Bridge
- **3. Resolution to Receive Funding ARPA Grant:** Required by NC Department of Environmental Quality in order to receive ARPA grant funds for the stream restoration

#### **Project Overview**

- The project is located in Barnardsville near the intersection of NC HWY 197 and Paint Fork Road as well as the nearby intersection of Dillingham Creek, Ivy Creek, and the North Forks of Ivy Creek.
- Due to proximity to these waterways, Barnardsville has long been subject to flooding events and was severely impacted by Tropical Storm Fred in 2021.
- Over time, the infrastructure (mainly the bridge and culvert) have aged and is deteriorating.
- The area includes the U.S. Post Office, Barnardsville Elementary School, Ohio Electric Motors, Inc., and the frequent flooding impacts education, economic development and resident well-being. Overtime the creek bed has moved as depicted below.




#### **DOT Agreement**

- **Scope:** Barnardsville Bridge Construction Project <u>costs \$3,400,000</u> <u>total.</u> The DPS grant will contribute \$2,831,000. Per the Agreement, <u>DOT will contribute the remaining amount.</u>
- Funding: The DPS Grant will <u>passthrough</u> Buncombe County to DOT
- Notes:
  - Preliminary engineering has started
  - DPS funds will be disbursed quarterly
  - Reporting is due to DPS quarterly. DOT will supply the report for the County to submit.
