#### **Executive Summary**

The Buncombe County Juvenile Crime Prevention Council (JCPC), in fulfillment of the duties and responsibilities as set forth in the General Statutes of the State of North Carolina, has reviewed and updated this County Plan for FY 2024-2025. In 2019, House Bill 593 passed which approved an optional 1 or 2-year funding cycle for DPS JCPC funds, which is determined locally by each JCPC statewide. Also included in the HB was Raise the Age in N.C. which directs 16 & 17 years old from District Court to Juvenile Court. In order to see any new possible trends in juvenile justice data (now serving 16 & 17 year old) and to plan programming in the community accordingly, the Buncombe County JCPC approved a 2-year funding cycle. Data continues to be monitored by the JCPC annually which provides direction to which funding cycle is most beneficial to the community and Council.

The JCPC has identified the issues and factors which have an influence and impact on youth and families who are involved in juvenile court, and those vulnerable or at-risk of juvenile court involvement in Buncombe County. Further, the JCPC has identified the strategies and services most likely to reduce/prevent behavior that could lead to court-involvement.

Monitoring and Evaluation: Each program funded in the past fiscal year by the JCPC has been monitored by the JCPC Monitoring Committee and most programs were found in full compliance with DPS JCPC Policy and within the operating parameters of their budget and, providing the services as described in their program agreement. The monitoring results and program outcome evaluations were considered in making funding allocation decisions. The JCPC will continue to conduct annual implementation monitoring of its funded programs.

<u>Priorities for Funding:</u> Through reviewing the Youth Assessment Screening Inventory (YASI) data, and a community resource assessment, the JCPC determined that the following services are priorities to serve youth who are court-involved and to reduce/prevent future involvement:

Priority 1: Restitution / Community Service

Priority 2: Comprehensive Clinical Assessments (CCAs) / Individual or Group

**Counseling / Substance Use Counseling Services\*** 

Priority 3: Teen Court

Priority 4: Interpersonal /Experiential Skills

Priority 5: Vocational Skills

**Priority 6:** Restorative Services / Restorative Justice\*

Priority 7: Parent / Family Skill Building

Priority 8: Structured Day/Tutoring/Academic Enhancement/Mentoring\*

Priority 9: Runaway / Temporary Shelter

The Buncombe County JCPC shifted towards a 2-year funding cycle last year, so all but one of the JCPC programs were allocated funds through FY24–25. This meant that the funds available to allocate for FY25 were limited to the priorities in **bold**, as other priorities are included in programs funded for 2-years. The was an initial Request for Proposals (RFP) released in January for \$73,357.

Monitoring reports were presented in February, and there was one program whose monitoring report did not recommend the program for continued funding. Given that, the JCPC voted to discontinue funding for the program for FY25 and to release a second RFP for the \$66,893 previously proposed for that program. Priorities listed above with an asterisk\* were included in this second RFP released in March.

<u>Funding Recommendations:</u> Having advertised two Request for Proposals (RFP) for prioritized services, each for a minimum of thirty (30) days, the JCPC has screened the submitted proposals and has determined which proposals best meet the advertised needed services. As required by statute, the JCPC recommends

allocation of the NC Department of Public, Division of Juvenile Justice and Delinquency Prevention funds to the following programs in the amounts specified below for the upcoming fiscal year: (Also, see the Buncombe County Funding Plan with this report.)

#### Part I. Youth Assessment and Screening Instrument (YASI) Summary

The Planning Committee reviewed aggregate data from Youth Assessment and Screening Instrument (YASI) assessments from July 1, 2022, through June 30, 2023. This is a measurement tool administered by Juvenile Court Counselors after youth are referred with a complaint alleging that a delinquency act has occurred and before adjudication of the youth. The YASI is an assessment that measures risk, need, and strength/protective factors in youth who are referred to the juvenile justice system, used for measuring risks related to recidivism and developing service plans. The assessment addresses twelve domains: Legal History, Family, Basic Needs, School, Community and Peers, Alcohol and Drugs, Mental Health, Physical Health, Aggression, Attitudes, Skills, and Employment and Free Time.

The full YASI assessment consists of over 100 separate items useful for both predictive risk and case management, so data reported from this review consists of county-level risk factors that may be prioritized by the JCPC for RFP development, as well as for highlighting prevalent issues among court-involved youth that individual programs and community-based organizations will want to consider when working with youth in the county. The aggregate outputs from full YASI assessments are one of the data sources used by the Committee and are the focus of summaries that follow in this document. YASI questions are framed in either a historical context (Legal History, for example), or in some cases, "current" or "prior three-months" timeframes for other, more dynamic, questions.

According to the US Census, the approximate population of youth ages 6-17 for Buncombe County is 33,167. During the fiscal year of 2022 - 2023, Buncombe County Juvenile Court Services staff completed 526 YASI assessments. The data provided below is based on the risks, needs, and strengths that are noted at the first assessment by Juvenile Justice at intake:

#### **General Observations and Points of Interest**

There is both a pre-screen assessment and a full assessment, however in Buncombe County it is standard practice for all court-involved youth to receive the full YASI assessment at intake.

<u>Risk Level</u> – 65% of the 526 assessed youth exhibited low risks. This is higher than the state's rate of 39%.

 $\underline{\text{Needs Level}} - 82\%$  of the 526 assessed youth exhibited very low to low needs. This is higher than the state's rate of 53%.

Strengths Level -81% of the 526 assessed youth exhibited high or very high strengths levels. This is higher than the state's rate of 53%.

Compared to the state, Buncombe County has much higher numbers of youth being referred to DJJ with low risk levels, very low needs, and very high strengths. There are also concerns regarding the high percentage of school-based complaints filed in Buncombe County compared to the state (see "School Domain, Q3 – School-Based Complaints" on p.2), and recent reports demonstrating inequities in school discipline and referrals to court (see linked Buncombe County Racial and Ethnic Disparities Data Presentation).

Consistent with research across the country, in May 2023 the NC Sentencing and Policy Advisory Commission published a Juvenile Recidivism Study (<u>linked here</u>), which noted: "the lowest levels of recidivism correspond[] to the least invasive systemic responses of the juvenile justice system, particularly by intervening with youth short of adjudication... this report and past report findings indicate the most efficient and effective investment of sufficient resources is in the community, at the front end of the juvenile justice system."

#### YASI Elevated Risks, Needs, & Strengths:

#### **Legal History**

**Q4** <u>Felony Referrals to DJJ</u> – 14% of the youth assessed had a felony referral. This is significantly lower than the state's rate of 36%.

**Q6** <u>Previous Weapon Offense</u> – 7% of the youth assessed had a previous weapon offense. This is an increase from the previous year (6%) but is lower than the state's rate of 17%.

#### **Family Domain**

- Q1 Runaway from Home or Placement 12% of youth reported incidents of running away. This is a decrease from 15% the previous year. While under the NC average (21%), it is still of concern especially given gaps in community services.
- Q4 <u>Family Alcohol/Substance Abuse</u> 12% of the youth assessed had family members with alcohol and/or substance abuse issues compared to the state's rate of 15%.
- **Q4** <u>Family Member Legal History</u> 33% of the youth assessed had family members with prior history with the criminal legal system compared to the state's rate of 29%.
- **Q7** <u>Parent/Custodian Supervision</u> 94% of youth assessed in Buncombe reported good/some supervision compared to the state's rate of 78%.

#### **School Domain**

Q1/Q10 School Enrollment Status -2% of youth assessed were suspended at the point of assessment (NC -3%). However, over the previous 2 years, 74% had been assigned one or more OSS (NC -65%) and 43% had been assigned one or more ISS (NC -36%).

**Q2** School Attendance – 17% of youth assessed had 5 or more unexcused absences. This is close to the NC average of 26%.

Q3 School-Based Complaints – YASI assessments showed much higher numbers of complaints filed by schools than the state. Only 7% of youth assessed experienced interventions by school administrators – this is down from 17% last year and less than 12% across the state. 49% of youth assessed had police reports filed by school, which is significantly higher than the state average of 27%.

Q4 <u>Academic Performance</u> -18% of youth assessed had C- or lower grades (NC -14%), 12% were failing some classes (NC -18%), and 12% were failing most classes (NC -17%).

Q12 <u>School Activities</u> – 38% of the youth assessed were interested in school activities but they were not involved in those activities. This is higher than the state's rate of 29%. 33% of the youth assessed had no interest and were not involved in school activities; which is comparable to the state's rate of 34%.

#### **Community & Peers Domain**

Q1 Peers/Associates – 23% of youth assessed reported spending time with friends who have a negative influence, while 10% of youth assessed reported having no friends or companions.

**Alcohol/Drugs Domain** – The following data from the alcohol/drug domain represents youth who answered "Yes" to alcohol and/or drug use. Out of youth assessed for Buncombe County, 29% of youth answered "Yes" to alcohol and/or drug use.

Q1 Age at 1<sup>st</sup> Use – Of the youth who answered "Yes" to alcohol and/or drug use: 11% reported being under 12 years old at first use compared to 10% across the state; 85% reported first use between the ages of 12-15 compared to the state's rate of 78%.

Q1 <u>Use Disrupts Function</u> – 25% of the youth who answered "Yes" to alcohol and/or drug use stated that the usage disrupted their daily functions – an increase from 18% the previous year. This typically indicates that treatment is warranted. The state's rate was 29%.

Mental Health Domain -42% of Buncombe youth assessed answered yes to having mental health problems and to being diagnosed with a mental health disorder, compared with 41% of youth assessed across the state. 29% of youth assessed were currently receiving mental health treatment.

**Q5** <u>History of Abuse</u> (by a parent including biological, step, adopted, and legal guardians) – 9% of the youth assessed reported a history of physical abuse, compared with the state's rate of 10%. 9% of youth assessed reported a history of sexual abuse; higher than the state's rate of 7%.

**Q6** <u>Victimization History</u> (by a peer or older person) -6% of youth assessed reported experiences of sexual vulnerability.

#### **Aggression Domain**

Q1 <u>Violence</u> – Of Buncombe youth assessed, 5% had displayed a weapon (NC 10%), 3% had used a weapon (NC 8%), 9% had indications of bullying/threatening (NC 24%), 7% of destruction of property (NC 14%), 47% of assaultive behavior (NC 41%), and 2% of assault with a serious injury (NC 5%).

#### **Employment and Free Time Domain**

Q1 Employment – 24% of youth assessed were currently employed, 66% had never been employed, and 15% reported prior successful employment.

**Q5 & Q6** Free Time – 25% of youth assessed participated in one or more structured activities, and 33% participated in one or more unstructured activities.

#### Part III. Summary of Gaps and Barriers in the Continuum of Services

- **Restitution/Community Service** to address needs for positive peer support and provide diversion and restitution pathways for court-involved youth. *Earn and Learn is a necessary service used regularly by court services; not available without JCPC funding.*
- Comprehensive Clinical Assessments (CCAs) / Individual or Group Counseling / Substance Use Counseling Services to address the need for youth coming through DJJ to access timely assessments and mental/behavioral health services. Buncombe County Youth Justice Clinical Program is a new JCPC-funded program to address CCA, individual/ group/ and substance use-related counseling needs.
- **Teen Court** to address school conflict and the need for positive peer support. *Teen Court is a diversion used regularly by court services that also receives referrals directly from schools.*
- **Interpersonal and Experiential Skill-building** to address school conflict, the need for positive peer support, mental health needs, and conflict in the home. *Kids at Work! and PIVOTPoint are JCPC-funded diversion programs that support building these skills*.
- **Vocational Skill-building**, particularly to address needs for employment and structured activities. Currently offered through other community programs. JCPC-funded programs The Connection and Kids at Work! include vocational skill building as well.
- Restorative Services/Restorative Justice, particularly to address school conflict, needs for positive peer support, and to provide alternative responses to reduce school-based complaints for youth with low risks, low needs, and high strengths. Restorative practices are being implemented in some schools, however, there is a need for more Restorative Justice diversion programs / alternative pathways away from court referrals.
- Parent/Family Skill Building, particularly to address histories of abuse and/or victimization, conflict in the home, and the need for family supervision skills. Currently offered through other community programs. Services addressing problems of sexual behavior are provided by TASK (Treatment Alternatives for Sexualized Kids).
- Structured Day / Tutoring / Academic Enhancement / Mentoring, particularly to address needs related to school conflict, attendance, academic performance, and desire for involvement in activities. Academic tutoring and mentoring are offered through JCPC-funded Partners Unlimited Structured Day, and several non-JCPC funded programs.
- Runaway / Temporary Shelter to address needs related to incidents of running away from home or placement, history of abuse, and the need for family supervision skills. There is not a primary resource for temporary and runaway shelter for youth in Buncombe County. When needed, DJJ is currently using community placements funded by other sources.

#### Part IV. Proposed Priority Services for Funding

The committee compared the services needed to address the elevated identified risks and needs with services currently available in the community. Priorities were determined, in part, based on ranking dispositional alternatives as top priorities, then diversion programs, and finally other needed services. Through reviewing the Youth Assessment Screening Inventory (YASI) data, and a community resource assessment, the JCPC has determined that the following services are priorities to serve youth who are court-involved and to reduce/prevent future involvement:

**Priority 1:** Restitution / Community Service (Earn & Learn)

Priority 2: Comprehensive Clinical Assessments (CCAs) / Individual or Group

**Counseling / Substance Use Counseling Services** (Youth Justice Clinical Program)

**Priority 3:** Teen Court (Teen Court)

**Priority 4:** Interpersonal /Experiential Skills (Kids at Work!, PIVOTPoint)

**Priority 5:** Vocational Skills (The Connection)

**Priority 6:** Restorative Services / Restorative Justice

**Priority 7:** Parent / Family Skill Building

**Priority 8:** Structured Day/Tutoring/Academic Enhancement/Mentoring (Buncombe

Structured Day)

**Priority 9:** Runaway / Temporary Shelter

The Buncombe County JCPC shifted towards a 2-year funding cycle last year, so all but one of the current JCPC programs are funded through the coming FY24 - 25 (the Youth Justice Clinical Program was a new program and so was only eligible for one year of funding). This means that the JCPC funds available to release in FY24-25 will be limited to the funds currently allocated to one program.

Given the limited funds available for FY24-25 and the assessment of current needs and gaps of services, the planning committee recommends the following services in ranked order be approved as funding priorities in FY24-25:

Priority 2: Comprehensive Clinical Assessments (CCAs) / Individual or Group

**Counseling / Substance Use Counseling Services** 

**Priority 6:** Restorative Services / Restorative Justice

These funding priorities are recommended in response to ongoing mental and behavioral health needs, as well as concerns regarding the high percentage of complaints filed for youth with low levels of risk and need, high strengths, paired with high percentage of school-based complaints. The committee recommends increasing alternative pathways to respond to youth behavior and needs, including through behavioral health and restorative justice opportunities, increasing access to other JCPC-funded programs through direct referrals from community members, and increasing awareness of community-based resources available to support youth.

#### **Buncombe County Juvenile Crime Prevention Council – Request for Proposals**

The Juvenile Crime Prevention Council (JCPC) studied risk factors and needs of youth involved in Juvenile Court in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Dept. of Public Safety (NCDPS) in the amount above to fund the program types specified below. Programs will serve court-involved youth and youth at-risk of court-involvement for the **fiscal year 2024-25** beginning on or after **July 1, 2024**. The use of these funds **require a local match of 30%.** 

Based on identified needed programs and possible gaps in the <u>service continuum</u>, the following program types will be considered for funding:

- 1) Comprehensive Clinical Assessments (CCAs) / Individual or Group Counseling / Substance Use Counseling Services
- 2) Restorative Services / Restorative Justice

Programs that reduce risks, address needs, and increase protective factors for youth will be considered for funding. Elevated risks and needs identified for youth in Buncombe County by the Youth Assessment Screening Instrument (YASI) include the following: (See linked Summary Risk & Needs Report, December, 2023)

- Need for positive peer influence, friends, and companions.
- Mental Health (including history of abuse and victimization)
- Alcohol/Substance Use (Age at 1st use and support those whose use disrupts function)
- Family Alcohol/Substance Use
- Assaultive behavior
- Runaway from Home or Placement
- Employment and Free Time (including increasing participation in structured and unstructured activities)
- School Enrollment, Attendance, Conflict, Academic Performance, Engagement with Activities

#### Applicants should provide:

- Program services that are shown to be effective with youth and families involved with the juvenile justice system (see NCDPS JCPC Minimum Standards here).
- Program services are outcome-based and have an evaluation component.
- Awareness of and sensitivity to Racial and Ethnic Disparities that exist in the County.

Only local public agencies, 501c3 non-profit organizations and local housing authorities will be considered for funding.

Interested organizations are required to complete an online application at the NC Dept of Public Safety website NC ALLIES. Application instructions are linked here and here. #### **Youth Justice Clinical Program, Buncombe County Justice Services**

NAME OF COMPONENT: Group Counseling

**BRIEF DESCRIPTION:** The Youth Justice Clinical Program provides group counseling via trauma-informed Motivational Interviewing, Cognitive Behavior Therapy, and Dialectical Behavioral Therapy to at-risk, delinquent, and adjudicated youth. The program addresses delinquent behaviors, family functioning, and other barriers and improves youths' ability to effectively cope with complex traumatic experiences. **NAME OF COMPONENT:** Comprehensive Clinical Assessment **BRIEF DESCRIPTION:** The Youth Justice Clinical Program addresses the continuum of needs by providing extensive behavioral health assessments. Comprehensive Clinical Assessments ensure that youth receive the most accurate recommendation for future services to meet their individual situation. These services provide rapid access to assessments with priority given for youth involved with Juvenile Court Services or youth at risk of court involvement.

#### NAME OF COMPONENT: Individual Counseling

**BRIEF DESCRIPTION:** The Youth Justice Clinical Program addresses the continuum of needs by providing extensive behavioral health counseling. Individual counseling services ensure that youth receive the most appropriate level of care to meet their individual situation. This service provides access to individual counseling with priority given to youth involved with Juvenile Court Services or youth at risk of court involvement.

#### Umoja and UNETE Restorative Practices Program, Umoja Health Wellness & Justice Collective

**NAME OF COMPONENT:** Umoja and UNETE Restorative Practices Program **BRIEF DESCRIPTION:** Umoja Health Wellness & Justice Collective (www.umojahwj.org) and UNETE (www.unetenc.org) will deliver evidence-based restorative services for youth and families engaged with Juvenile Justice in Buncombe County. Based in trauma-informed and resiliency-based curriculums at both organizations, we will deliver flexible services within the following modes: mediation, conferencing between affected parties, and circles to reduce recidivism, prevent future complaints, heal trauma, & share resources.

#### **PIVOTPoint WNC Prevention, PIVOTPoint WNC**

NAME OF COMPONENT: Afterschool Prevention

**BRIEF DESCRIPTION:** PIVOTPoint WNC (PPWNC) offers therapeutic adventure-based interventions to youth ages 14 and older who are at risk of court involvement. This is a preventative, skill-building program using evidence-based programming, including CBT, Experiential Coaching, Adventure Therapy, Mindfulness-based practice, Acceptance and Commitment Therapy, and Person-Centered therapy. It introduces personal agency development and pro-social skills, reducing substance use and recidivism.
