The Buncombe County Juvenile Crime Prevention Council (JCPC) studied risks, needs, and strengths of youth involved in Juvenile Court and hereby publishes this RFP. The JCPC anticipates \$644,477 from the NC Dept. of Public Safety (NCDPS) to fund program types listed below that serve court-involved youth and youth at-risk of court-involvement. The JCPC will approve 1-to-2-year awards (FY25-FY27) beginning on or after July 1, 2025, depending on JCPC approval and programs meeting all requirements. **Local programs must provide a match of 30%.**

Based on identified needed programs and possible gaps in the [service continuum](#), the following program types will be considered for funding:

- Need for positive peer influence, friends, and companions.
- Mental Health (including history of abuse and victimization)
- Alcohol/Substance Use (Age at 1st use and support those whose use disrupts function)
- Family Alcohol/Substance Use
- Assaultive behavior
- Runaway from Home or Placement
- Employment and Free Time (including increasing participation in structured and unstructured activities)
- School Enrollment, Attendance, Conflict, Academic Performance, Engagement with Activities

Applicants should provide:

- Services that are effective with youth and families involved with the juvenile justice system and align with NCDPS JCPC Minimum Standards (linked [here](#)).
- Services that are outcome-based and have an evaluation component.
- Awareness of and sensitivity to [Racial and Ethnic Disparities in the County](#).

Only local public agencies, 501c3 non-profit organizations and local housing authorities will be considered for funding.

The JCPC announces the availability of allocations totaling \$644,477 in state funding for local nonprofits and public agencies working to serve youth involved with the juvenile justice system. The JCPC addresses the gaps in youth services by promoting intervention, treatment and aftercare strategies and programs which support youth, strengthen families, and advance community safety. The North Carolina Department of Public Safety's Division of Juvenile Justice partners with JCPCs in each county to galvanize community leaders to reduce and prevent youth involvement with the juvenile justice system. The intent is to provide alternatives to youth development centers through community-based programming, treatment, counseling or rehabilitation services for youth involved in, or at risk of involvement, in the juvenile justice system.
