Guidance by Industry:

Restaurants:

Executive Order 163, Section 6- 3.2.b.

The lesser of:

- 50% of stated fire capacity or
- 12 people for every 1000 square feet of total square footage (including non-guest space) or
- The maximum number of patrons who can maintain 6ft between persons

Retail:

Executive Order 163, Section 6- 3.2.a.

The lesser of:

- 50% of stated fire capacity or
- 12 people for every 1000 square feet of total square footage (including non-guest space) or
- The maximum number of patrons who can maintain 6ft between persons

Bars, Nightspots, Arenas:

Executive Order 169, Section 3.2.d.

The lesser of:

- 100 people per outdoor setting (indoor operations are closed) or
- 30% of the facilities stated outdoor occupancy or
- 7 people for every 1000 square feet of outdoor space
- Maximum number of patrons that allows for 6ft of distance between parties

Gyms, Fitness and Physical Facilities:

Executive Order 169, Section 3.5.c.

The lesser of:

- 30% of stated fire capacity or
- 7 people for every 1000 square feet of total location or
- The maximum number that can maintain 6ft between persons

Movie Theaters, Meeting Spaces, and Entertainment Facilities:

Executive Order 169, Section 3.8.d.

The lesser of:

- 100 people per room (MUST BE SEATED EVENT) or
- 30% of stated fire capacity or
- 7 persons for 1000 square feet of event space square footage or
- The maximum number that can maintain 6ft between parties

Personal Care, Grooming, Tattoo Business

Executive Order 163 Section 6-3.4.b.

- 50% of stated fire capacity or
- 12 people for every 1000 square feet of total square footage (including non-guest space) or
- The maximum number of patrons who can maintain 6ft between persons
