The front lawn has a sign saying "WNC Community Health Services" in green letters.

Going East - Take I-240 East to Exit 2, which is marked "West Asheville". At the end of the ramp turn left onto Hanover St. Stay on Hanover St. until you come to a traffic light at the intersection with Haywood Rd. Turn right onto Haywood Rd. Stay on Haywood Rd. for approximately 1/3 mile. The clinic is located at the intersection of Haywood, Beverly, and Ridgelawn Roads. (This intersection makes a big curve to the left.)
