Approval of Agenda & Minutes

Public Comment

Residential Waste Collection

- Franchise waste collections contract started Jan. 1, 2020. It's a 5 Year contract with (2) 2 year extension options
- Weekly trash and every other week recycling collection in the unincorporated areas of Buncombe County
- Waste Pro is under an exclusive contract but it is not mandatory and based on subscribership. Residents who do not subscribe elect to self-haul material to transfer station or landfill.
- Waste Pro direct bills customers for services (quarterly, trash and recycling roll carts are provided.
- Basic service subscriber fee was \$19.21/month at start of contract, with CPI increase, new subscriber fee for CY 2022 is \$20.54/month.
- Current subscriber count: 30,395 Premium Service subscriber count: 76 Backdoor subscriber count: 444
- Increasing costs in fuel and labor shortages have been challenging the past two years.

Innovative Solar Projects

- Chairman Newman shared a document with a proposed schedule for floating solar project in Buncombe County.
- Floating solar arrays tend to generate more electricity than ground solar arrays because the temperatures are cooler. Floating solar arrays can also increase the amount of clean water supply and capacity.
- Chairman Newman asked if the Subcommittee would like to make a formal recommendation to the Board of Commissioners.
