Insolvent list of Tax Bills

for the 2013 Tax Settlement

North Carolina general statute 105-373(g)(h) allows the governing body of any taxing unit, in its discretion, to relieve the tax collector of the charge of taxes owed by persons on the Insolvent list that are five or more years past due...and Classified Motor Vehicle tax bills that are more than one year past due when it appears to the board that the taxes are uncollectible.

The Insolvent list of tax bills shown below are "Personal Property" tax bills for the tax years of 2003 through 2007, and Motor Vehicle tax bills for the tax years 2010 and 2011. Efforts have been made to find and contact all property owners shown for each tax bill. These tax bills are deemed uncollectable and permission is requested from the Tax Director to have the noted tax bills removed from the County's receivable list of tax bills.

There are a total of 229 Personal Property tax bills and 75 Motor Vehicle tax bills shown on the list with a total amount of \$50,113.58 being requested for removal.
