#### • School Capital Fund Commission

Max Queen, Chair, provided details of the work of the commission and highlighted some of the projects and accomplishments. The commission collaboration of the two school systems and the County has been informative and successful.

#### **PUBLIC HEARINGS**

#### Local Fiscal Recovery Fund - Economic Development Allocations

Tim Love, Intergovernmental Relations, explained the economic development appropriations. The appropriations include: \$50,000 to Asheville Area Arts Council for Creative Sector Recovery Grant Program; \$375,000 to Eagle Market Streets Development Corporation for Community Equity Fund; and \$1,250,000 to Self Help Ventures Fund for Mountain Community Capital Fund. Each of these projects are intended to create and retain jobs in response to substantial negative economic impacts from the pandemic. These projects were approved by the Buncombe County Board of Commissioners at its November 16th meeting for funding with American Rescue Plan Local Fiscal Recovery Funding.

The Chairman opened the hearing at 6:23 p.m.

Vice Chair Whitesides moved to approve the Eagle Market Streets Development Corporation for Community Equity Fund allocation as presented. Commissioner Wells seconded the motion and it passed 7-0.

Commissioner Wells moved to approve the Self Help Ventures Fund for Mountain Community Capital Fund allocation as presented. Commissioner Edwards seconded the motion and it passed 7-0.

Avril Pinder, County Manager, announced the upcoming Budget Retreat and the schedule for the Festival of Lights.

## **OLD BUSINESS**

 Resolution Approving the Memorandum of Agreement (MOA) between the State of NC and Local Governments on Proceeds Relating to the Settlement of Opioid Litigation

Michael Frue, Senior Staff Attorney, and Commissioner Beach-Ferrara detailed the resolution and the allocation. Commissioner Wells moved to approve the resolution as presented. Commissioner Edwards seconded and the motion passed 7-0.

# • Affirming the Extension of the Face Covering Requirement

Chairman Newman explained that the extension was based on the recommendation from the Public Health Director, Stacie Saunders due to the upcoming holidays, rising cases, new variant uncertainty.

Vice Chair Whitesides moved to affirm the Extension of the Face Covering Requirement. Commissioner Beach-Ferrara seconded and the motion passed 6-1. (NOES-Pressley)

#### **NEW BUSINESS**

#### Selection of Vice Chair

Vice Chair Whitesides nominated and moved to elect Commissioner Edwards as vice chair. Commissioner Beach-Ferrara seconded the motion and it passed 7-0.

#### • FY22 Affordable Housing Services Program Reallocation

Matt Cable, Planning Manager, explained the reallocation of \$128,500 in FY22 Affordable Housing Services Program funds to support Tenant Based Rental Assistance programs operated by the ARC of Buncombe County, Eblen Charities, and Eliada Homes.

Commissioner Edwards moved to approve the reallocation. Commissioner Wells seconded and the motion passed 7-0.

## Approval of COVID Premium Pay Policy

Heather Parkinson, Strategy and Innovation, explained that In September 2021, the BOC approved \$1,040,000 in ARPA funding for COVID premium pay for Buncombe County employees who met certain criteria. Since then, staff has been awaiting further guidance from the Federal Government on eligibility requirements for COVID premium pay. Unfortunately, specific Federal guidance has not been provided; however preliminary guidance has provided staff with enough information to proceed with allocating funds to employees. This payment is intended to reward County employees who worked in high-risk, public facing positions during the first 12 months of the pandemic (March 10, 2020-March 10, 2021), prior to a time when vaccines were available to reduce the risk of infection.

Commissioner Beach-Ferrara moved to approve the COVID Premium Pay Policy. Commissioner Wells seconded and the motion passed 7-0.

#### Budget Amendment for Community Development Staffing and County-Owned Property Feasibility Studies

Chairman Newman explained the budget amendment.

Commissioner Sloan moved to approve the budget amendment as presented. Commissioner Wells seconded and the motion passed 7-0.
