#### Resolution Authorizing the Execution of Special Warranty Deeds to Buncombe County Board of Education

Michael Frue, Senior Staff Attorney, explained that the reason for the resolution is the indebtedness secured by these properties have been satisfied, and pursuant to agreement of the parties, Buncombe County is required to re-convey the properties to the Buncombe County Board of Education.

Commissioner Wells moved to approve the budget amendment as presented. Vice Chair Edwards seconded and the motion passed 7-0.

## • Resolution Authorizing the Execution of Non-Warranty Deed to Asheville City Board of Education

Michael Frue, Senior Staff Attorney, explained that the reason for the resolution is the improvements are completed, and, pursuant to agreement of the parties, Buncombe County is required to re-convey the Properties to The Asheville City Board of Education.

Commissioner Whitesides moved to approve the budget amendment as presented. Commissioner Wells seconded and the motion passed 7-0.

## Resolution Authorizing the Execution of an Amendment to the Design Build Construction Contract Between Buncombe County and Astroturf Corporation

Tim Love, Interim Recreation Services Director, explained that the agreement needs to be amended by updating the scope of the project and increasing the amount to be paid under the agreement from \$3,500,000 to an amount not to exceed \$4,754,726. The reason for the increase is the cost of turf procurement and installation which were impacted by inflation and supply chain issues.

Commissioner Pressley moved to approve the resolution as presented. Vice Chair Edwards seconded and the motion passed 7-0.

Commissioner Sloan moved to approve the budget amendments as presented. Commissioner Whitesides seconded and the motion passed 7-0.
