The property would move from R-3 and R-LD (Residential), NS (Neighborhood Service) and CS (Commercial Service) to EMP (Employment) at 176 E Frederick Law Olmsted Way and an unaddressed parcel on Brevard Road in Candler. The total acreage of the two parcel property is 764.52. Biltmore Farms Attorney, Robert Oast, provided more details of the rezoning.

Vice Chair Sloan moved to approve adoption of the revised Affordable Housing Services Program Description, Requirements, and Guidelines for FY2025 funds with addition of the following text modification under the **Updated Loan Agreement Requirements**:

Must May apply for property tax exemption with Buncombe County regarding property associated with the project prior to completion (where the applicant is eligible to seek property tax exemption)

Commissioner Edwards seconded and the motion passed 7-0.

• Resolution Regarding Annual Examination of Bonds

Michael Frue, Senior Staff Attorney, explained that the Board of Commissioners is directed to carefully examine bonds of the Tax Collector, Finance Director, Register of Deeds, and Sheriff officers on the first Monday in December of every year to determine whether the security has been impaired, or for any cause to become insufficient to cover the amount of money or property or to secure the faithful performance of the duties of the office.
