• Community Development Block Grant (CDBG) Coronavirus Program Close Out

Stoney Blevins, Health & Human Services Director provided details of the program close out. The County received \$900K in funds through the CDBG Coronavirus Program in August 2021. Mortgage and/or utility assistance was provided to 206 unique households in the amount of \$495,781. The grant period ended June 2023 with a balance of \$404,212 unencumbered and the Board is required to close out the grant by taking action after a public hearing.
