Brief Project Description*

Eagle Market Streets Development Corporation, CDC seeks, 750,000/2 Yrs.--Support for a flexible financing tool that offers equity not debt. EMSDC's Community Equity Fund's (CEF), project seeks to address Buncombe County's strategic initiative: "small business and non-profit support.

Historically, BIPOC and Women business owners in the local market and region have been marginalized and underestimated. These businesses often lack access to conventional debt financing, or to "first in" dollars such as "friends and family" support. The challenge is highlighted by the gap in wealth for this population - Nationally: the average African American has \$12,000 in family assets, compared to \$141,900 for European American families. Simply put, our target entrepreneurs do not have access to the resources necessary to get their businesses to post COVID-19 viability.

This challenge remains unchanged since our initial application, in fact the need for patient, catalytic captial has increased.

Project Plan*

Explain how the project will be structured and implemented, including timeframe.

Design: Eagle Market Streets Development Corporation (EMSDC) and its Advisory Partners have collaborated to develop a finance model that will offer equity vs debt (and ongoing professional advisory support) to select historically underutilized businesses via an initial cash infusion and ongoing monitored advisory support until the company is in a position to use positive financial performance to gradually contribute back to the CEF's recirculating pool of funds to support more new candidates (3-5 years). The design creates a significant opportunity to create intergenerational wealth as the businesses thrive and grow.

Statistics: Research shows the wealth gap between African Americans and European Americans shrinks from 12x's to 3x's for African Americans who own a business. These businesses will not only build prosperity for themselves, they will produce job opportunities for their communities, thereby growing the local tax base. And, their presence and success will provide much needed modeling for prospective, aspiring, future business owners. *See Tapestry Report"

Implementation: Implementation: With funding from, Coronavirus State and Local Fiscal Recovery Funds (Recovery Funding), EMSDC's CEF will support an additional five to seven local businesses in each of the three years with equity capital, business advisory/acumen training and access to "virtual back-office" support to help with bookkeeping, human resources, and CPA and Legal needs. All

Equity Trust agreements are approved by CEF Equity Approval Committee comprised of former bank and CDFI individuals with prior traditional lending expertise--committee is currently 99% women from these indcustry sectors.

Timeline: Contingent on a expedient signing of our contract CEF will be able to deploy these funds as early as 4th quarter of 2022. *We are currently awaiing a deposit of funds from our first award--expected on before April, 29, 2022.

Statement of Need*

EMSDC's CEF proposal seeks to address the deep rooted, historically--systemic wealth gap disparities for BIPOC and Women owned businesses: through increased job creation--above living wage, i.e., family wage and through preservation of local businesses that will continue contributing to the economic vibrancy of the county, the city and the region.

Historically, since 2004, Black African American business owners have remained at a disparate rate, in Buncombe County, the United States Census identified 858 Black-owned firms and 26,122 White-owned firms. The percentage of the population that owns a business is 7.2% for Blacks and 14.2% for Whites. (US Census Bureau, 2012)", (https://stateofblackasheville.com/economics-entrepreneurship-poverty/). Note that while this data is listed on the "State of Black Asheville", 2019 capture for the 2012 Census, this suggest the disparity could be greater.

The need to protect these viable but fragile businesses owners is imperative for a minimum of two significant reasons: 1.) This business population was experiencing challenges of lack of capital long before the

pandemic, COVID illuminated these challenges and threatened near extinction for some of these businesses. For firms with receipts less than \$500,000, minority firms experienced loan denial rates of 42 percent compared to those of 16 percent for non-minority firms. (https://www.ncjustice.org/wp-content/uploads/2018/12/BTC-HUB-BUSINESSES.pdf) [1] 2.) The current climate gives us the first opportunity since 1921/24 to allow BIPOC businesses to become job creators and greater contributors to sustainability of the economics of their communities and community at large. (https://interise.org/wp-content/uploads/BridgingtheWealthGap.pdf). [2] Recovery funds, if awarded will allow a seasoned Economic Development Corporation, in collaboration with public private partners, to drive the restoration and retention of historically underestimated businesses and their communities.

Link to COVID-19*

Identify a health or economic harm resulting from or exacerbated by the public health emergency, describe the nature and extent of that harm, and explain how the use of this funding would address such harm.

EMSDC is a long term economic development practitioner and a service provider for underestimated, underfueled BIPOC and Women owned small businesses. Working closely with these businesses we were keenly aware of the impacts of COVID on this marginalized group. Our target audience for this grant proposal remains, BIPOC and women owned businesses that have been disadvantaged by years of systemic biases, preventing them from receiving the resources necessary to protect themselves in normal times and found these challenges were exacerbated by the pandemic. According to the HUB (Historically Underutilized Business) COVID Report, (https://files.nc.gov/ncdoa/documents/files/NC-HUB-COVID-19-Impactv3.pdf), 68% of businesses surveyed reported a 50% decrease in revenues due to COVID. An additional challenge is these businesses tend to historically service type businesses.

CEF seeks to address the harm presented by COVID, historic systemic challenges and institutionalized barriers to these underfueld businesses. CEF offers them a unique and innovative opportunity, the program provides "equity capital" for eligible participants--businesses 3/5 yrs. of operations, trending at \$100K or greater in annual revenues and who show a positive history of repay. The majority of our inagrual cohort were viable businesses with postive balance sheets and liquidity, but could or did not want to add debt to their books. With CEF funding these businesses--to date have created 13/above living wage jobs and have increased their annual gross revuenues by 12/15%, well above the 7% growth required by CEF for repay. *Another 15+ job to be created, is pending--one business is awaiting an award of a contract with the US Forestry Service.

Population Served*

Our target audience for Recovery Funds, if awarded, are local, Buncombe County and surrounding county BIPOC and women owned businesses. Demographic makeup of our initial cohort was: a commercial landscaper, a co-working coffee shop and an event and food establishment--99% local businesses, one business from a nieghboring county. These businesses were funded with generous support from the Dogwood Health Trust (DWHT). *The majority of businesses served by EMSDC CEF, are those with relationships established well before the pandemic. *DWHT has invited CEF to apply for it new RFP, "Accelerating Underfueld Business--up \$750K/3 yrs.

County ARA Recovery Funds will allow EMSDC CEF to expland its capacity to support its target audience and support businesses not represented by typical service sectors--restaurants, beauty salons, retail shops (exception, those who have the desire, ability to create innovative expansions for these type businesses-, i. e., Barber/Beauty Salons, create or expand to Barber/Beauty Schools, restaurant or retail shops that create or offer apprenticeship opportunities).

Results*

CEF measures will focus on, job creation/retention, living/family wage, increases in business revenues and increase in income and benefits for employees. Additionally, businesses will increase their annual gross revenues by a minimum of 7% to ensue adquate repay of CEF equity infusions.

*Note for every person of color, with one business owner in the family, the wealth gap decreases by 75% from >12% down to 3%.

Evaluation*

EMSDC formed solid relationships with the businesses which comprised the inaugrual cohort and will continue this course of action with all future cohorts. Many of the businesses we have been cultivating, nurturing relationships for more than 3-5 years.

Our quality assurance measures will be tied to wrap-around, business acumen, advisory support. We have a strong network of service providers, to include, not limited to: Mt. BizWorks, CDC, Edward Jones Financial, Ten Biz Consulting, LLC and Carolina Small Business Development Fund (CSBDF). Additionally, we have a built-in team of business advisors led by our Fund Manager. CEF Fund Manager is a liaison to the Equity Approval Group. He is responsible for onsite monitoring, and regular monthly, quarterly check-ins with the businesses. He has designed data-tracking mechanism to capture data analysis that will inform us and allow us to offer "real help in real time" response to our businesses.

The initial phase of this investment may not make a significant impact on overall increase of Black and Brown entrepreneurship or job creation in the region--currently at or < than 2%/per county or area to be served. However, investments provided by AARA, will allow the Buncombe County Commissioners and the other organizations involved to prove the model on a manageable scale, while allowing CEF Fund to build additional support--capital from other entities, locally, regionally and globally. CEF's desire is to create immediate-term resiliency for established businesses and to generate an opportunity for lasting, long-term and significant wealth building for Buncombe County and surrounding communities.

CEF is the perfect vehicle to create equitable, sustainable communities. As an expansion of the EMSDC's Individual Development Account program and it's Community Benefit Partner Program, CEF continues the

organizations commitment to asset building and wealth creation in underestimated communities. More simply stated, CEF will provide the opportunity for community business owners to build generational wealth for themselves, their families and their communities.

EMSDC's most significant experience for managing this type of funding is its Eagle Market Place, LLC project. With funding from Federal, State, County/City, foundation and private funds the organization and their partner, Mountain Housing Opportunities, Inc. completed a 20.8 million dollar edifice in downtown Asheville, NC. The project consists of 62 units of mixed income housing, 9,000 sq. ft. of commercial lease space and 7,000 sq. ft. of community space; (currently residential and commercial space is at 100% lease up). Additionally, EMSDC's liquid assets under management total approx. 2.8 million of which 50% is a combination of Federal, State, and local municipal funding.

EMSDC has successfully operated small business support through its Individual Development Account (IDA) for small business program--2004/present (approx, 298 enrollees/189 graduates); Community Benefit Partner (CBP)--fiscal spnosorship program--current assets under management--approx, 2.8M and Incubate to Innovate (I2I)--subsidized commercial leasing for emerging small businesses desiring to lease in downtown Asheville-


