- There was a discussion about the presentation including:
- How are other counties handling the funding and how long they have been in existence?
- Suggestion of an additional slide to give more info on what a model might look like.
- How does this play into the work that ABPPC has been doing for years? Will there be 2 systems developed at the same time that will compete for funding?
- How will Federal Universal PreK initiative trickle to our community?
- Data shows 7%-13% ROI
- Need to be clear that this is not a monetary ask at this time. Suggest including there will be a funding model developed in the planning phase.
- Jasmine Beach-Ferrara made a motion for the committee to endorse the group's recommendation with noted revisions. Rich Johnston seconded the motion. Motion was unanimously approved by roll call vote with Kit Cramer abstaining from vote due to not being present for the entire presentation.
