Quarter 1	Therapeutic interns are collaborating with three centers—Children's Center of WNC, JCC, and Christine Avery—to provide play-based therapy. Meanwhile, consultants focus on assisting programs in creating welcoming and inclusive classroom environments by coaching teachers and utilizing materials in both English and Spanish. We also provide culturally relevant books and activities to support this effort. Recently, we held a training session at Evolve, guiding educators on how to use visuals to meet the differing abilities of students, ensuring more inclusive teaching practices.
Quarter 2	Consultants continued to work closely with educators and directors to enhance classroom inclusivity by providing coaching and materials in both English and Spanish tailored to desired outcomes. Clinical interns continue to support children through play-based therapeutic support, providing essential services to promote emotional well-being. Consultants provided visual aids to the centers and further developed a yearly resource calendar featuring culturally diverse activities, such as Day of the Dead celebrations. These resources, paired with articles and tools, aim to deepen educators' understanding and implementation of inclusive teaching practices. In the middle of this quarter, Hurricane Helene significantly disrupted our efforts and the operations of partnering centers, temporarily halting some initiatives. Despite these challenges, we followed up on our Evolve training, ensuring educators effectively use visuals to address students' differing abilities. Our ongoing initiatives continue to promote welcoming and inclusive learning environments across all centers, adapting to unforeseen circumstances to maintain our impact.
