Organization Description	<ul style="list-style-type: none"> In 1907, the YWCA of Asheville formed as a boarding home for women coming into the city to work. Since then, the YW has responded to the changing needs of community and impacts over 3,000 individuals per year. The YWCA of Asheville is dedicated to eliminating racism, empowering women, and promoting peace, justice, freedom, and dignity for all. The YWCA works to accomplish this mission by providing programs that help bridge gaps in education, earning power, health and wellness, and access to childcare for low-income and/or minority families in community.

Now working to expand Swim Equity Program to even more children in the community that may otherwise never be exposed or have access to this life-saving skill.

The spreadsheet will also track each student's competency level every week focusing on levels 1 and 2 include floating on front and back, streamlining, arm mechanics, leg mechanics, whole stroke, and treading in semi-deep water. If a student is not performing well in an area or is not progressing to the next level, the spreadsheet will document what they are struggling with and why, so that the issue can be addressed. 85% of students who receive swim lessons from the YWCA will reach a level of swimming competency and water safety by demonstrating water comfort, basic swimming skills, breath control, comfort floating, and increased endurance.

In 1907, the YWCA of Asheville formed as a boarding home for women coming into the city to work. Since then, the YW has responded to the changing needs of our community and impacts over 3,000 individuals per year. The YWCA of Asheville is dedicated to eliminating racism, empowering women, and promoting peace, justice, freedom, and dignity for all. The YWCA works to accomplish this mission by providing programs that help bridge gaps in education, earning power, health and wellness, and access to childcare for low-income and/or minority families in our community. In 2018 the YWCA partnered with Asheville City Pre-School to continue our Swim Equity Partnership offering 234 low-income students the opportunity to learn to swim after school and has continued that partnership through 2018-19. In 2018 the YWCA also celebrated 111 years of eliminating racism and empowering women!

Project Description

What do you propose to do? What is your plan? What are your goals?

Drowning is the leading unintentional cause of death for children under four. African-American children ages 5-19 are almost six times more likely to drown than white children of the same age. This inequality is historically rooted in racism including slavery, the Jim Crow laws of the American South, and today's anglicized ideas of beauty. Since the early 1950s, the YWCA of Asheville has been teaching children of color to swim. We were one of the first pools in WNC to integrate and we continue to provide one of the few diverse pools in the area today. The YW has taught generations of families to swim in an effort to combat the shocking inequities in drowning deaths among children. We are now working to expand our Swim Equity Program to even more children in the community that may otherwise never be exposed or have access to this life-saving skill.

Key Steps*

How will the project work? What are specific activities and milestones that your project entails?

Funding from the Buncombe County Strategic Partnership Grant will allow us to continue the program, offering 32 weeks of swim instruction per year to 238 children through Asheville City Preschool(ACPS), Asheville Middle School's In Real Life (IRL) Program, and participants in the YWCA's Early Learning Program (ELP). Through these initiatives we will address the inequality in drowning deaths, the inequity in access to recreational facilities and instruction, and promote a low-impact form of physical activity among a population that is at a greater risk of obesity and other health issues.

This project will serve District 1, represented by Al Whitesides and Jasmine Beach-Ferreira. Targeted partners are Asheville City Preschool, and the YWCA's Early Learning Program.

People Served*

Who are the members of our community this project will serve? How many people will be served? Include demographics, including age, area median income, race, neighborhood and/or school.

We will offer 16 weeks of swim instruction -- one session in fall (8 weeks) and one session in spring (8 weeks). Each session will serve 208 Asheville City Preschool students and 30 students through IRL. Though the YW offers swim scholarships to the community, it can still be hard for families to access these programs. By serving children through programs they are already involved with - ACPS, IRL, ELP, SALSA, and PEP- we are reaching children who would not otherwise have access to quality swimming lessons. Children benefiting from scholarships will primarily be preschool students ages 3-5.

Partners*

The YWCA has begun a successful partnership with Asheville City Preschool. We have collaborated to create a thoughtful design for the program that will best address the needs of the population we serve. The program launched in January 2018 and we look forward to a lasting partnership between the YWCA and Asheville City Preschool. Other area organizations offer swim lessons and scholarships to the community it can still be hard for families to access these programs. By serving children through programs they are already involved with such as Asheville City Preschool and the YWCA's Early Learning and, we are reaching children who would not otherwise have access to quality swimming lessons.

Personnel*

Who is responsible for the project? Briefly describe project leaders and the role each will play in the project. How do these leaders reflect the population or community that you serve?

Project leaders include the YWCA's Aquatics Director, Kitty Schmidt. Kitty has worked for the YWCA for over 17 years and has been full time for 4 years as our Aquatics Coordinator. Kitty supervises a staff of lifeguards and swim instructors and makes sure everyone is up-to-date on their certifications. She keeps the pool in great shape, regularly passing health inspections with no findings, and expertly manages our extensive pool schedule of lessons, classes and open/lap swim.

Success*

Each student's age and race will be tracked in a Google spreadsheet. The spreadsheet will also track each student's competency level every week focusing on levels 1 and 2 include floating on front and back, streamlining, arm mechanics, leg mechanics, whole stroke, and treading in semi-deep water. If a student is not performing well in an area or is not progressing to the next level, the spreadsheet will document what they are struggling with and why, so that the issue can be addressed. 85% of students who receive swim lessons from the YWCA will reach a level of swimming competency and water safety by demonstrating water comfort, basic swimming skills, breath control, comfort floating, and increased endurance.

In 2018 we reached our goal of serving 186 participants in the program.

Funding*

What is your plan for finding the balance of the project budget? What is your funding timeline and what are your other sources of support?

The cost to provide 238 students with swimming lessons will be \$39,592. We are also requesting \$25,000 from Asheville City's Strategic Partnership Fund. We will use the remaining \$408 to purchase swimwear and goggles for each student.

Sustainability*

How will this project be maintained? Please describe funding sources and how you plan to sustain the project in future years.

YW's 110 year history, financial leadership, and resiliency predict future sustainability. The organization has no long-term debt, a strong asset to liability ratio, and a diverse revenue stream. Over the past 4 years YW completed a Financial Sustainability Plan, a business plan, and a Strategic Plan. Most recently we completed the CCAT, Core Capacity Assessment Tool, through WNC Nonprofit Pathways. With quick implementation, we turned around deficits caused by changes to the voucher system for school aged children. We invested in a fundraising model to increase individual gifts through tours and an annual luncheon. In the past three years we've raised over \$679,000 in cash and five year pledges. The Aquatics program will continue to be supported by program fees, contributions, and rental income. The YW's pool has carried a deficit for many years. By expanding our community programming we will reduce our deficit as we continue to address the racial disparity in drowning deaths.
