Current individual Circle of Security Parenting classes are happening for 4 individuals. Three monthly Circle of Support gatherings took place with up to 5 parents and 8 children in attendance each month. Three monthly Circle of Support gatherings occurred for teachers at Lonnie D Burton, who completed the Circle of Security Classroom training in December. A Circle of Security Parenting group will start in April with the hope that 8-10 participants will be in attendance. The educator is coordinating with community public libraries for multiple special story times to share books, activities, and resources for caregivers related to teaching children and caregivers about the importance of consent and boundaries as prevention strategies. Goal 3: The Community Educator will participate 24/yr. collaborative community associations. Qtr. 3- 7 meetings, <u>On Target-Buncombe County Children's Collaborative</u> , <u>Buncombe County Child Protection Team, Child Fatality Review, FJC Operations, Multidisciplinary Team, National</u> <u>Prevention Consortium.</u> Goal 4: Adults will receive training on recognizing and reporting child abuse, 500 adults/yr. <u>Off Target-5 Participants completed the Stewards of Children training in the 3rd quarter.</u> Darkness to Light Stewards of Children training is now an updated training course that is 2.5 hours long. The updated Stewards of Children training, 2.5 hours, is an obstacle to finding participants. Community Educator has 2 Stewards of Children training scheduled for April; one free community training planned to recognize Child Abuse Prevention Month and another a training geared for professionals working with children and families; the training will be hosted by MAHEC. Sixty-one early educators participated in a Connections Matter t

Currently Circle of Security Parenting classes are happening for 4 individuals. One Circle of Security group took place in the 4th quarter, 6 participants completed the program. Six Consent Story Times were shared across multiple Buncombe County library branches, reaching over 100 caregivers/children; books, activities and resources for caregivers related to teaching children and caregivers about the importance of consent and boundaries as prevention strategies were shared. Goal 3: The Community Educator will participate 24/yr. collaborative community associations. Qtr.4- 4 meetings, On Target-Buncombe County Children's Collaborative, Buncombe County Child Protection Team, Child Fatality Review, Multidisciplinary Team, IDD Advocacy Coalition. Goal 4: Adults will receive training on recognizing and reporting child abuse, 500 adults/yr. Off Target-99 Participants completed the Stewards of Children training in the 4th quarter. Community Educator facilitated 7 Stewards of Children trainings in the 4th quarter, one free community training to recognize April, Child Abuse Prevention Month. A Stewards of Children training geared for professionals working with children and families hosted by MAHEC. Additionally, a training for Guardian Ad Litem volunteers, Camp Lakey Gap staff, members of Buncombe County Children's Collaborative, Camp Cadi staff, and Helpmate Shelter staff.
