FOSTER PARENT TRAINING:

After you have attended a foster parent orientation and feel ready to become a foster parent, training is the next step in the process. The training program called MAPP (Model Approach to Partnerships in Parenting), is a 10 week course that prepares you to become a licensed foster parent.

- Helping Children with Attachments & Birth Family Connections
- Understanding the Impact of Fostering or Adopting

ABOUT FOSTER CARE:

The best place for a child to be is with a family. The truth is that there are some children who cannot safely live with their birth parents.

When relatives cannot provide a safe home for these children, foster parents become the temporary family for them. If the child is unable to safely return to their birth family, a foster parent can become the adoptive family.

No matter where you live, there is a child in foster care close by who is in need of a safe and stable home.

Who are the children in care?

All children in foster care have been abused or neglected or may have no one to care for them. They have all experienced loss and unpredictability.

These children are 0 -18 years old and are all races, genders, and religions. They have favorite foods, activities, and sense of style.

Foster parents do not have to be:

Married, rich, own a home, a certain race, gender, or ethnic group.

Foster parents need to:

Love kids, communicate well and have the time to take care of a child's needs



Supports for Foster Parents:

Foster parents get a monthly stipend for the child's day-to-day needs. See our website for the current amounts.

Children in care receive Medicaid to cover all healthcare related needs. We offer day care and after school vouchers for parents who work.

Each foster parent is connected to a licensing worker. Support is available, 24 hours a day from our agency. We also provide ongoing training opportunities throughout the year.

Our licensing workers will connect you to other foster parents who can support you

Becoming a foster parent is a rewarding and important calling. The challenges can be big, but the rewards are even bigger. Being a foster parent is something that *you CAN do for a kid*!
