Item Two – Tally Write-in Ballots


- Director Velez presented to the Board a total of thirty-eight (38) precincts with ballots from Election Day that have write-ins to be tallied. Velez stated that upon research if a candidate runs in a Primary of a nonpartisan municipal race and lose your name will still be counted if it is written-in in the General Election.
- Director Velez recited G.S. 163-182.2 (2) and that our current software does not allow for the tallying of write-ins for precincts on election night.
- Two tallying teams of four tallied the ballots of the thirty-eight (38) precincts with write-ins.
- Director Velez presented a total two (2) Absentee two to be tallied.
- Two tallying teams of four tallied the ballots of the two (2) Absentee ballots with write-ins.
- Director Velez presented ballots from each of the six (6) One-Stop sites that have write ins to be tallied.
- Two tallying teams of four tallied the ballots of the six (6) One-Stop sites with write-ins.

- Chairman Watson inquired whether all calls and marks were clearly heard and seen, and the tallying teams answered affirmatively and the Board signed off on the tally sheets.
