Item Two - Approval of Minutes

- Member Keller motioned the minutes to be approved as amended for November 7, 2017 and the Board was in unanimous agreement.
- Member Keller motioned the minutes to be approved for November 13, 2017 morning session and the Board was in unanimous agreement.

 - Two (2) Previously Removed One Inactive After Two Federal Elections, One Removed Administratively


- One (1) Staff Error
- Mrs. Duncan presented the twenty-four (24) ballots recommended to not be approved.
 - Thirteen (13) No Record of registration.
 - Seven (2) Jurisdiction Dispute
 - Two (2) Removed
 - One (1) Voter Already Voted
- Mrs. Duncan stated that an elderly voter voted the second day of early voting and then came back two weeks later not remembering that they voted. The voter was issued a provisional ballot.
- Chairman Watson reminded staff and the visitors that while ballots are being duplicated, the room is to be silent to avoid confusion and assure accuracy.
- The duplication team duplicated two (2) provisional ballots and tallied three (3) write-in ballots.
- Chairman Watson inquired whether all calls and marks were clearly heard and seen, and the duplication team answered affirmatively.
- Member Keller made a motion to accept the recommendation of the staff to accept the forty-three (43) that were recommended not to be approved and the Board was in unanimous agreement.
- Member Keller made a motion to accept the recommendation of the staff to reject the twenty-four (24) that were recommended not to be approved and the Board was in unanimous agreement.


Item Four- Adjourn
