Meeting Minutes  
June 20, 2020

**Opening**

The scheduled meeting of the Buncombe County Board of Elections was called to order at 3:06 pm June 20, 2020 at 77 McDowell Street, Asheville, NC 28801.

In response to the COVID-19 threat and NC Stay at Home Order, the board meeting was held with limited in-person Board members and staff. The Board members and staff, along with the public, were in attendance over a virtual public access site hosted through the Public Teams meeting app. Directions on how to attend this virtual meeting were provided to the public on the Buncombe BOE website.

**Welcome Visitors and Introduction of Remote Meeting Features**

Chairman Jake Quinn welcomed virtual guests.

**Item One – Review and Approval of Minutes**

Member Block expressed displeasure with the minutes. Chairman Quinn postponed review/approval.

**Item Two – Office Update**

Director Duncan gave the following updates:

- SBOE Davey Lowman (In-Person Voting) is attending the meeting for he has been observing the in-person voting during Early Voting.
- Bria Bailey has accepted the Elections Technical position and is expected to start on July 13, 2020. She could not attend today's meeting as she is working in the Transylvania County Elections office.
- Summary of activities scheduled for today through Election Day:
  - Early voting ended at 3pm today (June 20, 2020). Staff is reconciling and conducting an audit, and will update voter history to include Early Voting voters in 250 Election Day computers. Staff member Kevin Roberts is in charge of this operation.
  - Current Board meeting to review and approve absentee ballots, along with One-Stop/Early Voting pollbook.
  - On Sunday (21<sup>st</sup>) and Monday (22<sup>nd</sup>), Chief Judges are picking up their Election Day supplies and any last minute reminders from 50 Coxe Ave., especially review of PPE requirements, new end of Election Day check-in process, and Express Voting.
  - Election Day
    - Board members responsibility
      - Polls are open from 6:30AM until 7:30PM. Board members must be able to be reached during this time by staff in order to address any issues.
      - Board meeting at 2PM for the counting of absentee ballots.
      - Signing of Absentee Results abstracts at 7:30PM.
        - Chairman Quinn expressed displeasure with waiting until 7:30PM to begin this process. Director Duncan explained staff will be beginning the process earlier and have the abstracts ready for signature at 7:30PM. She affirmed data is uploaded earlier in the day but not visible to the Public. SBOE Noce explained that results cannot be announced until 7:30PM and thus the Board must also wait for this announcement time. Member Watson mentioned that staff must not be interrupted by Board members while they are working on processing the results, allowing them to complete the Abstract of Results at the appointed time. Director Duncan reiterated she is trying to insure all the moving parts of Election Day will run smoothly, and attempting to reduce the rising stress during the day. SBOE Noce referenced several other counties had internal glitches which resulted in the delayed SBOE live posting of results in the March 2020 Primary.
    - Immediately following the signing at 7:30PM, the Board will divide into two bipartisan teams in order to oversee the return of materials by precinct officials. Board members will be assigned their individual responsibilities on Election Day.
      - Return of the physical election results (flash drives) to 77 McDowell Street office, along with properly uploading of drives into the system,

and once this has been accomplished, those Board members will move to 50 Coxe Ave to assist there.

- The proper return of ballots, along with other Election Day materials, to 50 Coxe Ave.
  - The Chain of Custody forms will be signed by the Board at 50 Coxe Ave.
- The Election Day materials return process has been streamlined, plus we have additional county employees helping with the check in process at 50 Coxe Ave. This should enable the process to be more efficient.

### **Item Three –Consideration of Absentee Ballot Applications Civilian, Overseas and Military**

Absentee process has been modified to adhere to social distancing and maintaining PPE protocol to keep all Board members and staff safe.

- Staff member Johnston presented 57 civilian absentee applications containing ballots and one overseas absentee ballot to be reviewed.
  - Board members divided into two bipartisan teams to review and approve the absentee ballot applications.
    - After the bipartisan Board team approval, the ballot was passed on to the four member ballot duplicating bi-partisan team. The team consisted of the following staff members: Kaylea Noce, Karen Rae, Kevin Roberts, and Corinne Duncan.
    - Chairman Quinn inquired whether all calls and marks were clearly heard and seen, and the duplication team answered affirmatively.
  - Absentee-1Stop Staff member Johnston presented the Absentee Pollbooks for Absentee-OneStop voting from June 16 2PM through 20<sup>th</sup> (589 voters).
    - The Board signed these pollbooks.
  - Director Duncan confirmed that Absentee-1Stop has been audited and balanced. The total of Absentee-1Stop voters was 1424 total votes.
  - The Board verified the sealed polybag containing the 57 original civilian absentee ballots and 1 overseas ballot.
  - The Board signed the Executed Absentee Ballot list audit log for the 57 civilian absentee ballots and 1 overseas ballot.
- Chairman Quinn motioned to approve the 57 civilian absentee ballots. The Board approved the absentee ballots unanimously.
- Chairman Quinn motioned to approve the 1 overseas ballot. The Board approved the absentee ballots unanimously.
- Chairman Quinn asked the Board to meet on July 14, 2020, to discuss the Absentee-1Stop voting locations for the General Election. Member Block stated that she would not be available for that date. Director Duncan suggested this possibly be a meeting to start the discussion.


Member Duncan expressed concern of time and effort may have to be repeated when meet again for finalizing. Chairman Quinn stated the board will discuss this at a future meeting.




