## Buncombe County Board of Elections Meeting Minutes July 2, 2020

## Opening

The scheduled meeting of the Buncombe County Board of Elections was called to order at 5:03 pm July 2, 2020, at 77 McDowell Street, Asheville, NC 28801.

## Welcome Visitors and Introduction of Remote Meeting Features

Chairman Jake Quinn welcomed virtual guests.

#### **Item One – Office Updates**

Director Duncan gave the following updates:

- General Assembly of North Carolina Session 2019 Session Law 2020-71 (Senate Bill 217) will prevent payments received by precinct officials and assistants working in the General Election between September 1, 2020 and November 5, 2020 from reducing unemployment insurance benefits.
- The sort of Early Voting Ballots into their reporting precincts has been completed. The law allows 30 days from the election to complete this sort and it has been accomplished ahead of schedule.
- The number of absentee requests received to date for the General Election is at approximately 4,500.

## Item Two – Provisional Ballot Meeting

Staff member Joyce Kanavel presented a summary of the provisional process and provisional recommendations. There are 104 total Provisional Ballots from the June 23, 2020 Republican 2<sup>nd</sup> Primary Election and no Pending Provisional ballots.

- 53 Provisional ballots recommended for approval
  - 45 incorrect precinct
  - 6 geocode issue (unrecognized address)
  - 1 incorrect Party (clerical error from 2001 and had not voted in a Primary since)
  - 1 voter already voted (worker error, should have been able to vote normally)

Board asked for clarification on the various definitions/reasons a provisional ballot was approved.

- 51 Provisional ballots recommended to not approve
  - o 30 Incorrect Party
  - 21 No record of registration

Member Duncan asked about the method of assuring the non-registered voters would become registered voters. Staff member Kanavel reported that the Provisional envelope applications will be scanned and serve as a voter registration form.

- Staff member Kanavel reviewed how the completed Provisional Ballot application form is on the front of the sleeved envelop, and the bottom portion of the form shows the research staff has completed to determine if the ballot should be approved or not. The Board reviewed the 104 Provisional Ballot envelopes.
- Staff members Noce, Fox, Young and Roberts assisted in the opening envelopes and preparation of the approved ballot to be scanned through the DS200. They also duplicated a ballot which had been folded in a way the DS200 would not accept.

Chairman Quinn motioned to approve the 53 provisional applications that were recommended for approval. Board member Watson seconded, and the Board approved unanimously.

Chairman Quinn motioned to deny the 51 provisional applications. Board member Watson seconded, and the Board was in unanimous agreement.

## GENERAL ASSEMBLY OF NORTH CAROLINA SESSION 2019

#### SESSION LAW 2020-71 SENATE BILL 217

#### AN ACT TO PREVENT CERTAIN PAYMENTS TO PRECINCT OFFICIALS WORKING IN THE 2020 GENERAL ELECTION FROM REDUCING UNEMPLOYMENT INSURANCE BENEFITS.

The General Assembly of North Carolina enacts:

**SECTION 1.** Payments received by precinct officials and assistants under G.S. 163-46 for work performed during the period from September 1, 2020, until November 5, 2020, do not affect the computation of the individual's partial weekly benefit under G.S. 96-14.2(b).

**SECTION 2.** This act is effective when it becomes law.






