Welcome Visitors and Introduction of Remote Meeting Features

Chairman Jake Quinn welcomed virtual guests.

Item One – Approval of Minutes

• The Board reviewed the Minutes of October 13.

Member Watson moved to adopt the minutes of October 13, the Board unanimously approved.

Item Two - Office Updates

- Staff member Noce provided the following updates
 - o The absentee team is staying caught up in processing and mailing out requests.
- Director Duncan gave the following updates after returning from the commissioners meeting.
 - o Absentee:
 - The office has received over 51,000 absentee by mail requests so far, over 7 times what was processed in 2016.
 - The office is now operating on a one day turnaround to get requests processed.
 - The team now has 10 full time employees; 35 part time employees & 50 volunteers working to make this happen.
 - More than 22,500 ballots have been returned so far.
 - o Early Voting:
 - There were 7,977 voters on the first day.
 - 44,000 people have voted so far; combined with the number of absentee by mail ballots that have been returned that makes 66,000 people who have voted in Buncombe County. There approximately 205,000 registered voters.
 - 275 poll workers working 2 shifts to make early voting a success.
 - Support staff include:
 - One coordinator with 4 rovers.
 - 4 people operating a call center.
 - 4 people answering the public line.
 - 5 person night shift.
 - 24,000 people have checked the wait map.
 - Harrah's Cherokee Center is the only site that is underperforming.
 - Haywood Street is impassable due to construction;
 - Early voting information has been added to the marquee at the Cherokee Center.

- Director Duncan is working on making it known that there is one hour of free parking at the nearby parking garage.
- o Election Day:
 - Fully staffed with 650 poll workers including backups
 - Support staff include:
 - 2 supply coordinators
 - 10 rovers
 - Everyone at the office will be taking calls on Election Day
 - Emergency services stationed at election services.
- The State Board of Elections have issued updated numbered memos regarding the cure process. These memos can be found on the State Board website.

Item Four - Absentee Review

- Staff member Noce first presented to the Board for approval the UOCAVA ballots. There are 271 ballots in this category;
 - o 20 MIL and
 - o 251 OVR
- There were over 5,000 absentee by mail ballots set for approval for this meeting from return dates between October 8 and October 16.
- The zero tapes were presented to the board from the DS850 before any scanning occurred.
- At 5:53 pm, staff member Noce brought attention to the Board of a voter who spoiled her first ballot and requested a second one. She returned her second ballot in her envelope that was first issued. The CIV number does not match but it belongs to a single voter.

Member Block motioned to approve the presented ballot. Member Newman seconded the motion and the Board unanimously voted to approve the ballot.

The Board recessed for dinner at 6:15 and will reconvene in 30 minutes. The meeting reconvened at 6:51PM.

• 3,415 ballots were scanned in the first night, including the 271 UOCAVA ballots.

Item Four - Continuation of Absentee Review

- The Board resumed reviewing and opening absentee envelopes beginning with ballots from Precinct 44.1.
- At 4:25 pm staff member Noce presented an envelope which contained the wrong ballot which was discovered after it was opened by board members. Staff located the envelope that corresponded with the ballot in question, and it was from a member of the same household, but was checked in for a future Board meeting. Staff member Noce recommended to the Board that they agree to move that ballot to the current board meeting so that it would meet all the requirements of the policy passed during the October 13 board meeting.

Chairman Quinn moved to reassign the ballot to this meeting so the two ballots would meet the requirements of the policy. The Board unanimously passed the motion.

- At 6:06 pm precinct 16.2 needed to be rescanned because a voter who submitted a ballot by mail had voted in person at a one-stop site.
- The Board members checked the number on the DS850 machine to ensure that the number of absentee ballots scanned was also the number reviewed, the Board members agreed that the numbers matched.
- Staff member Noce presented the Board with the following ballots recommended for disapproval;
 - Envelopes that contained ballots whose CIV numbers did not match and did not meet the requirements of the policy.
 - O The ballot of the voter who had gone to vote early.
 - The ballots of voters who have since passed away.
 - O Ballot return envelopes where the signatures did not match the voter because the voters swapped envelopes; the Board reviewed each of these swaps, there were 14 in total, 7 pairs. The Board discussed the possibility of accepting the ballots as it was similar to the CIV swap.

Chairman Quinn moved to disapprove the 14 swapped ballots and that the voters be contacted. The Board voted 4-1 to pass the motion, Member Block dissented.

- A ballot that was pending cure; the voter's assigned ballot was returned in a household member's envelope and was reviewed and disapproved at an earlier meeting.
- One damaged envelope, and one ballot returned in a CVI envelope which is not a valid method of return.

Chairman Quinn moved to disapprove the remaining 12 ballots. The Board unanimously passed the motion.

 Staff member Noce then brought to the Board the two ballots from last meeting whose registration had been denied.

Chairman Quinn moved to disapprove the two ballots so the voters could be contacted. The Board unanimously passed the motion.

- The Board members were presented with the zero tapes from the beginning of the meeting as well as the final report of the number of absentee-by-mail ballots scanned during this meeting.
- A total of 28 absentee-by-mail ballots were disapproved during the meeting.

Chairman Quinn moved to approve the 5,423 ballots that were scanned during the meeting, Member Watson seconded and the Board passed the motion.

Item Five - Continuation of Approval of Board Meeting Schedule

• The Board discussed the meeting schedule through November 13.

Chairman Quinn moved to adopt version 8 of the board meeting calendar; the Board unanimously adopted the updated calendar. A copy of the calendar is attached.
