- 1. Is there some assurance that we can (or should) offer in case the contract is canceled: reimbursement of any cancellation fees or bond expenses. **OWNER IS CONSIDERING. TO BE ANSWERED IN FINAL ADDENDUM.**
- 2. Confirm asbestos report in the specifications **THIS IS INCLUDED IN THE ORIGINAL BID SPECS.**
- 3. Duct insulation for the ductwork that we are raising up on that weird section of roof what have we specified? Is the existing duct insulated, does it have a metal jacket? Has the design team specified a metal jacket? Do installers even need to reinsulate anything or just repair anything that is damaged during removal/reinstallation SEE M001 FOR NEW DUCT NOTES. EXISTING INSULATION AND METAL JACKET CAN BE REPAIRED IF DAMAGED.
- 4. Can EPS insulation be glued for a fully adhered system? EPS SPECS AND INFO WILL BE ADDRESSED IN FINAL ADDENDUM
- 5. What should the schedule duration be from Notice to Proceed? **240 DAYS.**
- How are we choosing the low bidder? Base bid? Base Bid and Alternates selected? Is the escalation included? Do we have different escalations for different alternates? INTENTION IS TO SELECT FROM BASE BID AND ANY ALTERNATES CHOSEN. THIS WILL BE CLARIFIED IN FINAL ADDENDUM.
- 7. Do any of the stairs to remain need to be raised? (the bottom of the existing stringers) SEE KEYNOTE 8 ON A191, A192, A193, A194, A195. ADD "MODIFY STRINGERS OF EXISTING STAIRS TO BE 1" CLEAR OF FINISHED ROOF MEMBRANE. GRIND AND SAND ALL SHARP EDGES. REPAINT AS REQ'D."
- Should we get a 3rd party RRO (registered roof observer)? Weekly 3rd party QA? NOVUS WILL BE PROVIDING WEEKLY QA VISITS.
- 9. How many crews can AB Tech stand on the roof at once? i.e., are they happy if they have three cranes set up and operating at one time? GC AND ROOFING OPERATIONS MUST COORDINATE WITH THE OWNER TO ALLOW REQUIRED ACCESS AND EGRESS FOR TENANTS. IT IS NOT THE OWNER'S INTENT TO LIMIT ROOFING ACCESS BEYOND THESE REQUIRED OPERATIONS.
- 10. Can we include material costs for edge metals in the escalation clause for roofing materials? **TO BE ANSWERED IN FINAL ADDENDUM.**
- 11. Can you please issue a new bid form that includes the price escalation percentage and any membrane or allowance changes? **BID FORM ATTACHED TO ADDENDUM #3**
- Please confirm that "Pollution insurance" is truly required for this project. It will add 13K to the cost. The only time we have previously needed it was for a water treatment project. TO BE ANSWERED IN THE FINAL ADDENDUM.
- 13. Is the drain inspection & report due before or after the reroof? DRAIN INVESTIGATION AND REPORT SHOULD BE PROVIDED AT THE START TO INFORM THE NECESSSARY REPAIRS.
- 14. Is a Temp field officed required (per specs)? **TEMP FIELD OFFICE CAN BE LOCATED WITHIN THE BUILDING. NO JOB TRAILER IS REQUIRED.**

- 15. Specs call for a 3" max insulation thickness 075423-7, there will be 6" of base layers of insulation (2 layers). There will be 13" of tapered insulation, eliminating this max thickness spec for the tapered insulation (only) will cut the cost of adhesives considerably saving roughly 90K. NOTE THAT THE SPECIFICATION SECTION IS REFERRING TO POLYISO, WHICH IS PRODUCED IN MAX 3" SHEETS, TYPICALLY. IF OTHER MATERIALS ARE ACCEPTED, THEN STANDARD MANUFACTURED THICKNESS ARE ALLOWED. WE DO NOT WANT CUSTOM POLYISO (OR ANY OTHER INSULATION) THICKNESSES.
- 16. Are the any specs for the EPS. Most manufactures will require a minimum 1.25# density. EPS SPECS AND INFO WILL BE ADDRESSED IN FINAL ADDENDUM
- 17. For the Alt Metal roof (400 square feet) are shop drawings + stamped engineering required (per the specs)? These will cost more than the materials for that tiny roof. NO SHOP DRAWINGS AND STAMPED DRAWINGS ARE REQUIRED AS A PART OF THE STANDING SEAM DUMPSTER ROOF ALTERANATE.
- 18. For the Alt Metal roof specs call for (R-30) 6" total in 1" layers. The roof is not over enclosed space, do you really want insulation there? NO INSULATION IS REQUIRED AS A PART OF THE STANDING SEAM DUMPSTER ROOF ALTERANATE.
- The thickness for the prefinished steel Edge metals ranges from 26 gauge to 22 gauge. 076200-7 26 Gauge is a bit thin. Possibly reword requiring all prefinished edge metals to be 24 gauge and all cleats to be 22 gauge galvanized metal? PROVIDE 22 GAUGE PREFINISHED STEEL EDGE METAL, 22 GAUGE GALV STEEL CLEATS.

The document must include evidence of all good faith efforts that were implemented, including any advertisements, solicitations and other specific actions demonstrating recruitment and selection of minority businesses for participation in the contract.



 - f. Price Escalation Clause for Roofing Materials. Prime Bidders shall include a fixed escalation factor as a line item to the bid proposal form. This escalation factor shall be reflected as a percentage increase over 2021 Quarter 4 prices for roofing membrane, fasteners and adhesives and roofing insulation materials in response to unpredictable market conditions, uncommitted pricing from manufacturers and varied availability of material supplies which are influencing costs and project schedules industry wide. This clause acknowledges that this escalation factor may vary between bidders based on contractor preferred manufacturer source of materials and anticipated lead times.
 - g. Additionally, the prime bidder shall indicate a bid price for <u>roofing materials as stated above</u> the bid form to establish the baseline for which to apply the escalation when final pricing from manufacturers can be confirmed. This cost is to be for the materials as specified for the <u>base</u> <u>bid</u>. The contractor shall supply back-up documentation, invoices, manufacturer quotes or other papers to the Owner upon request. Further documentation will later be required by the Owner for any accepted bid alternates.
 - h. This escalation percentage and bid price applies to the <u>roofing materials as stated above</u> only and <u>will not</u> be used as factor for awarding the project based on the lowest responsible bid.
 - i. Should there be an increase in the price of roofing materials that are purchased for use in this project after the execution of the contract that exceeds the baseline cost provided on the bid form, the Owner agrees to pay the <u>actual</u> increase in cost of materials, <u>not to exceed</u> the declared escalation percentage included as part of the submitted bid. The contractor shall supply back-up documentation, invoices, manufacturer purchase orders and other papers to the Owner to verify the cost increase.
