What is SOAR Family Treatment Court?

Family Treatment Courts provide:

- 1) treatment & counseling
- 2) intensive case management
- 3) and judicial supervision to drug and alcohol addicted parents or guardians who are in danger of losing custody of their children due to abuse and/or neglect.

How can SOAR Family Treatment Court help me and my family?

The Family Treatment Court (FDTC) Team will coordinate the intensive therapeutic substance use treatment needed to help put you on the path towards recovery from addiction.

The FDTC Judge who will supervise your case through informal, non-intimidating proceedings, is a caring and supportive team member there to help build relationships and trust between parents and treatment team members.

We're here to keep you motivated! Our approach to treatment includes a system of incentives and sanctions that offer structure and provide predictable consequences for behaviors. As you move through the phases of FDTC treatment you will have many opportunities to set realistic recovery goals and learn and practice new coping skills that will help you reach those goals.

Our Goal is Your Goal

The goal of SOAR Family Treatment Court is to help reunite families after parents have successfully undergone treatment and counseling to become more stable in their behavior and recovery efforts. SOAR is here to help parents and caretakers overcome substance use and promote safety, well-being and permanence for children in their home environments.

Who is eligible for SOAR?

To be eligible to participate in SOAR Family Treatment Court, an individual must be:

- a parent/guardian who is 18 years of age or older
- willing to participate in SOAR Family Treatment Court
- a resident of Buncombe County
- parent who has a petition filed by DSS in juvenile court and the petition contains allegations of substance use
