**The Juvenile Crime Prevention Council having studied the needs of juveniles in the county hereby publishes this Request for Proposals.** The North Carolina Department of Public Safety (NCDPS) anticipates annual funds in the above stated amount will be available for programs serving delinquent and at-risk youth beginning on or after July 1, 2022. ***Awarded funds must be spent by June 30, 2023.*** Local match rate for JCPC funds required: **30%**.

**Based on identified needed programs and possible gaps in the service continuum, the following program types will be considered for funding:**
