
- 393 total individuals served during reporting period

- 1,579 criminal/civil justice system assistance instances



Total individuals served: 393





Polyvictimization* Types of Victimization

- There were 193 survivors who reported multiple victimizations
- There were 632 responses to the types of victimizations experienced by survivors
 - 57.3% (362) of survivor responses indicated survivor had experienced domestic violence
 - 22.3% (141) of survivor responses reported stalking/harassment
 - 13.0% (82) of survivor responses reported child physical abuse or neglect
 - 4.0% (25) of survivor responses reported adult sexual assault
 - 1.7% (11) of survivor responses reported child sexual abuse or assault

Types of Victimizations




^{*}Polyvictimization refers to having experienced multiple victimizations and emphasizes experiencing different kinds of victimization rather than multiple episodes of the same kind of victimization.



Special classifications

- 161 instances of special classifications
 - 39.1% (63) identified as homeless
 - 26.1% (42) identified as victims with disabilities
 - 12.4% (20) identified as victims with limited English proficiency
 - 9.9% (16) identified as immigrants/refugees/asylum seekers
 - 8.1% (13) identified as LGBTQ
 - 3.7% (6) identified as veterans



Services Provided – Information & Referral

- 2 individuals were assisted with information & referral services
- 9 information and/or referral instances were provided*:
 - 33.3% (3) provided information about the criminal justice system
 - 33.3% (3) provided referral to other victim service programs
 - 33.3% (3) provided referral information to other services, supports, and resources





Criminal/Civil justice System Assistance

- 393 individuals were provided criminal/civil justice system assistance services
- 1,579 criminal/civil justice system assistance instances:
 - 66.6% (1,052) engaged in assistance for a civil legal attorney in family law services
 - 17.0% (269) engaged in assistance for a civil legal attorney in restraining order services
 - 16.3% (257) were provided with other legal advice and/or services
 - 0.1% (1) was provided immigration attorney assistance
