Tipping Point Review Team

The review team will analyze and select new Tipping Point grant applications to support grassroots programs or ideas to strengthen our communities through these small, innovative grants.

Reviewers are selected based on the responses submitted for the listed five questions and statements. Reviewers must have a connection to Buncombe County either live, work, worship, or play here.

Criteria to be a member on the Tipping Point Review Team

- Be able to analyze grant applications effectively against specific criteria to support "Ensuring Positive Places," "Connecting People," and /or "Improving Equitable Opportunity."
- Be able to clearly express your comments and knowledge of each application.
- Be interested in contributing to the advancement of knowledge of community initiatives and Buncombe County expectations.
- Answer all five questions and provide your contact information.

Time Commitment

• This is a volunteer position. Time commitments vary depending on the grants under review and the number assigned. The team will meet on April 6th and April 9th from 5:30pm-7:30pm. Dinner will be provided. One additional voting session may occur if needed the week of April 13-17.

Peer Reviewer Requirements

Prospective peer reviewers must be:

- Willing and able to provide written and oral comments based on their knowledge of the specific criteria.
- You don't have to be an expert in the subject area to be reviewer.
- Must be able to attend all 3 review team meetings.

They must also:

- Be able to listen attentively to the input of other reviewers.
- Engage in discussion.
- Acknowledge differences.
- Work with other reviewers and respect their comments, especially when resolving discrepancies in scoring.
- Submit full disclosure of any conflicts of interest in writing. Conflicts of interest will be discuss before voting on any award decisions. Conflicts of interest include close professional or personal relationships with grant applicants.

In addition, potential peer reviewers must have the highest level of personal standards to:

- Maintain confidentiality.
- Avoid any conflict of interest.
- Ethically review all applications.
