A. Purpose

Buncombe County aims to revitalize Hominy Creek River Park to enhance recreational amenities, promote sustainability, improve water access and connectivity, and provide a safer, more enjoyable experience for residents and visitors. The selected firm will deliver full design and engineering services and guide the project through construction administration upon funding.

B. Project Summary

The scope includes but is not limited to:

- Master planning with some stakeholder engagement
- Providing design while working within the confines of a conservation easement
- Environmental and streambank restoration design
- Working within a conservation easement

- Upgrades to trail systems, river access points, and pedestrian connectivity
- Providing design for a new river craft access point
- ADA accessibility upgrades throughout the site
- Parking and entrance improvements
- Stormwater and erosion control infrastructure
- Wayfinding and educational signage
- Traffic/parking studies for the new expansion of the park
- Natural landscaping and habitat protection strategies
- Cost estimation for 100% construction documentation
- Preparation of 100% construction documents
- Permitting services including submittal, review, and fees associated with
- Bidding and construction administration (as needed)

The selected team will coordinate closely with County staff and community partners to ensure the design reflects the park's unique character, riverfront setting, and ecological sensitivity.

D. Qualifications

Selection will be based on team qualifications, relevant experience, capacity to execute the work, and understanding of the project. Applicants will be evaluated in conjunction with the anticipated needs of County and information provided by the applicants as well as information obtained from

references, persons, or other sources identified by the applicant or otherwise known by the County. Interviews may be held at the discretion of the County. Buncombe County anticipates selecting a single firm for the referenced work, followed by negotiation of service fees for the project.
